

Westminster Community Homes Intermediate Rent Horizon Scheme Policy & Guide 2024-25

1. Advertising and shortlisting

- 1.1 Properties will be advertised on the Homes for Westminster (HFW) website only. Applicants will be given a minimum of two weeks to express their interest in the property to HFW. HFW may also contact those registered on the waiting list by any of their marketing methods. You must check that you are qualify for our properties before confirming your interest.
- 1.2 Once the closing date for expressing an interest has passed, HFW will shortlist up to twelve applicants per property. This shortlisting is based on the Westminster Council priority banding, combined with the household income information held, household size and time on the waiting list.
- 1.3 HFW will contact the shortlisted applicants to confirm their current household income and household size before inviting them to the viewing to ensure they qualify.

2. Viewings

- 2.1 Group viewings will be held during Monday to Friday, and usually between 12pm-2pm. Applicants must bring their passport and a copy to the viewing so that identity can be confirmed.
- 2.2 Applicants must confirm to Homes for Westminster by 12pm the next working day if they wish to apply for the property.
- 2.3 Interested applicants will be put into priority order by HFW and WCH will be informed.

3. Successful applicant

- 3.1 WCH will contact the top placed applicant to begin the reference process.
 The applicant must do the following within two working days:
 - confirm who will be living in the property.
 - Inform current landlord and employer that will be contacted for references.
 - provide recent payslips and a photocopy of passport and visa if applicable.
 provide their full name and email address

The referencing company, FCC Paragon, will contact the applicant by email and the applicant is expected to respond within 48 hours to all requests. If five working days elapse and the applicant has not responded in full to the information requests, the property will be offered to the next highest placed applicant.

4. Deposit

4.1 Once the outcome of the referencing is determined, the successful applicant must pay a five-week rental deposit within 3 working days. The deposit money will be protected by mydeposits.co.uk which is a government approved deposit protection agency.

5. Withdrawing your interest

If you wish to withdraw your interest for the property once the deposit has been paid, then a holding fee will be payable. The fee covers our admin and void losses. This will be charged at the cost of one week's rent for every week that has passed up until your withdrawal.

6. Tenancy signs up

The tenant must then sign the tenancy with a start date no later than four weeks from the viewing or three weeks after the date of the successful reference check. The direct debit must be set up at the time of sign up. Rent payments are made in advance and the first rent payment will be due on the agreed tenancy start date.

7. Homes for Westminster

7.1 HFW is a unique service aimed at those who live or work in the Westminster area and want to get on to or move up the property ladder through purchasing or renting a property. The service was launched in April 2009 and to date it has helped over 1,250 households to find a home ownership or rental property within Westminster. Westminster Community Homes will only accept an applicant that has been referred from HFW.
